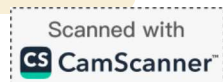

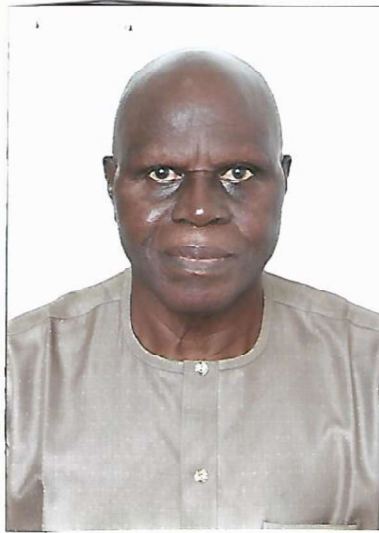

## COMPANIES & ALLIED MATTERS DECREE No. 1 OF 1990, PART C

### ADDITIONAL REQUIREMENTS

As a result of measures recently introduced with regard to the issue of Certificates of Incorporation to socio-cultural and voluntary organisations under the Companies and Allied Matters Decree No. 1 of 1990, Part C, an organisation applying for registration shall henceforth comply with the additional requirements set out below:-

1. *Public Notice* - (a) It is now the responsibility of organisations to issue public notices in at least three national newspapers as to its intention to apply for registration under the Companies and Allied Matters Decree No. 1 of 1990, Part C. One of the newspapers should be *Daily Times*, *The Punch*, or *New Nigerian*. Whilst one should be a local newspaper widely circulated in the area where the organisation is based. However, it is advisable for organisations to check for the acceptability of their chosen name before commencing action on their registration.

(b) The publications which should include the names of the Trustees, must also indicate the area of the country where the organisation is based.

(c) There should also be three publications of claim of ownership of a landed property by the organisation. The publication must be detailed enough to include the plan number and the survey beacons as well as clear description of the location of such landed property.

(d) Each of the publications in (a) and (c) above should call for objections, if any, which must be forwarded to the Registrar-General, Corporate Affairs Commission, P.M.B. 198, Area 11, Garki, Abuja within 28 days of the date of the publication.

2. *Appointment of Trustees*. - Appointment of Trustees should always be in accordance with the provision of Constitution of the Organisation. In forwarding the extract of the minutes of the meeting in which the trustees were elected Enclosure H (a), it is imperative to include:

- (i) the list of members present, and those who were absent at the meeting; and
- (ii) figure of votes scored by each elected trustees (i.e. votes for, against and abstentions).

3. *Affiliated Bodies*. - Details of current and past affiliated organisation (if any) as required in Enclosure H (c) should be furnished. Information as to the type of relationship (e.g. a branch), should also be given.

4. *Change of Name*. - When registered organisations decide to change their names the following procedures must be followed:

- (i) The organisation must make publication in three national newspapers as specified in paragraph 1 above.
- (ii) The organisation must display for at least 21 days a notice conspicuously mounted at the organisation's headquarters and, if any, at branch offices, or any such places where majority of the members are likely to see it.
- (iii) The publications and notices must call for objections which (if any), must be forwarded to the Registrar-General, Corporate Affairs Commission, P.M.B. 198, Area 11, Garki, Abuja within 28 days of the date of publication.
- (iv) Thereafter the organisation will formally apply to this Commission for the change of name by forwarding a copy of each of the notices.

5. *Replacement and Appointment of Additional Trustees*. - When a registered organisation (a) intends to replace some or all of the members of the trustees for any reason whatsoever or in compliance with the conditions stipulated in their constitution, (b) intends to appoint additional Trustee(s), it should, in addition to the procedures stipulated in paragraph 2 above, also publish in two national newspapers the reason(s) for the desired change as well as the names of the new or additional trustees as the case may be.

6. The completed application forms must be forwarded in triplicate.

7. Please note that the collection of an application form is not an acceptance of name.

COMPANIES & ALLIED MATTERS DECREE No. 1 OF 1990, PART C

MEMORANDUM FOR GUIDANCE OF APPLICANTS

It will be necessary for the body design to be registered to appoint one or more Trustees who shall make formal application for a Certificate of Incorporation under the Companies and Allied Matters Decree No. 1 of 1990 Part C.

2. *General Note:-* All applications should be submitted in this office form entitled "Enclosures A-H" attached to this Memorandum and should be accompanied by two printed copies of the applicant and by any other supplementary information which the applicant may wish to submit. Appendix A must be completed.

3. The application must be accompanied by *Seperate Enclosures to the Following Effect:-*

(a) **THE OBJECTS OF THE APPLICANT BODY**

(The objects for which an applicant body may seek to be incorporated are the advancement of any Religious, Literary scientific, social or charitable purpose and none other).

(b) The RULES of the Applicant Body which must be dated and signed, must include provisions as to the appointment and removal of Trustees, the particulars of their tenure of office and method of filling vacancies.

(c) The RULES of the Applicant Body which must include a provision for the winding-up of the organisation's business and therefore its removal from the register of organisations incorporated under the Act.

(d) An easily identified *description of the land held* if any, and the tenure of which it is held, or a similar reference to land which the body proposed to acquire.

(e) The full *Names, Residence and Occupation OF THE TRUSTEES*.

(f) In inverted comma, the proposed title of the applicant body in which the words "REGISTERED" and "TRUSTEES" must be included. It is SUGGESTED that the title should take a form similar to the following which has been approved:  
THE REGISTERED TRUSTEES OF.....

(g) The impression of the Common Seal. If the Common Seal is not yet ready, the Trustees should forward a drawing of the proposed device.

(h) The regulations for the use and custody of the Common Seal.

(i) A copy duly signed and dated by the Secretary of the relevant minute of the meeting whereat the Trustees were appointed.

Your RULES AND REGULATIONS relating to the Trustees should be made to incorporate provisions similar to the following:-

(a) The Trustees of.....for the purpose of the Companies and Allied Matters Decree No. 1 of 1990, Part C shall be appointed at a General Meeting (State what constitutes the General Meeting and Quorum) of the Meeting charged with responsibility of selecting the Trustees).

(b) Such Trustees (hereinafter referred to as "The Trustees" shall be in number and shall be known as "THE REGISTERED TRUSTEES OF .....

(c) The Trustees may hold office for life but shall cease to hold office if he:-

(i) Resigns his office.

(ii) Ceases to be a member of the registered Trustees of .....

(iii) Becomes insane.

(iv) Is officially declared bankrupt.

(v) Convicted of a criminal offence involving dishonesty by a court of competent jurisdiction.

(vi) Is recommended for removal from office by a board of Governor's and Trustees' majority vote of members present at any General Meeting of .....

OR

(vii) Ceases to reside in Nigeria.

(d) Upon a vacancy occurring in the number of Trustees, a General meeting will be held to appoint another eligible member of.....

(e) The Trustees shall have a common Seal. (The Seal must be metal). The impression of the Common Seal or a proposed device of it which you have been asked to submit should be submitted on a separate sheet of paper headed "ENCLOSURE "F" THE DEVICE OF THE COMMON SEAL".

(f) Such common seal will be kept in the custody of the Secretary (or whoever is desired) who shall produce it when required for use by the Trustees.

(g) All documents to be executed by the Trustees shall be signed by such of them and sealed with the common seal.

(h) The Trustees shall apply to the Corporate Affairs Commission for Certificate of Incorporation under the Companies and Allied matters Decree No. 1 of 1990 Part C.

(i) If such certificate is granted, the Trustees shall have power to accept and hold in trust, all land belonging to.....

.....and to acquire land on behalf of .....  
Subject to such condition as the Commission may impose.

9. If subscriptions or other contributions are to be collected from members provisions should be made in the rules for the keeping of accounts, their annual auditing and reporting of discrepancies to a General Meeting.

6. SPECIAL CLAUSE relating to income and property of applicant bodies should be incorporated in your rules. Copies of Minutes of the meeting where at the CLAUSE was adopted for incorporation in your rules should be supplied duly signed and dated by the secretary.

### ENCLOSURE "A"

#### AIMS AND OBJECTS OF THE APPLICANT BODY

1. The main Aim of PASTORS' TRAINING TRUST FUND is to train people that God has called and are ready to be used as instruments unto honour, by giving spiritual leadership and direction in this depraved world.
  - a) Pray for God to reveal those people that are willing to serve.
  - b) To assist individuals and corporate bodies with Christian background spiritually and financially.
  - c) Organise any constitutional means of gathering or raising funds towards training the potential or serving Pastors in need.
  - d) Where necessary, organise seminars and workshops to raise the level of awareness amongst the Christian Community about the necessity of Pastoral Training.
  - e) Give individual the opportunity to adopt a particular Pastor's training under the supervision of PASTORS' TRAINING TRUST FUND.
  - f) To undertake any administrative decision or actions that will and can ~~facilitate effective~~ pastor training.
  - g) To take any incidental or ancillary measures that can aid in achieving the afore-mentioned Aim and Objectives.

ENCLOSURE "B"

RULES AND REGULATIONS GOVERNING THE BODY

BOARD OF TRUSTEES:

1. The Trustees of PASTORS' TRAINING TRUST FUND for the purpose of The Companies and Allied Matters Act, No. 1, of 1990, Part 'C', shall be appointed at the General Meeting.

QUORUM: It shall be 2/3 majority vote of the members present at the General Meeting.

2. Such Trustees (hereinafter referred to as "The Trustees") shall not be less than Three (3) nor more than Ten (10) in number, and shall be known as The Incorporated Trustees of PASTORS' TRAINING TRUST FUND.
3. The Trustees may hold Office for life, but a Trustee shall cease to hold Office if he/she:-
  - a. Resigns his Office,
  - b. Ceases to be a member of The Incorporated Trustees of the Foundation,
  - c. Becomes Insane,
  - d. Is officially declared Bankrupt,
  - e. Convicted of a criminal offence involving dishonesty by a Court of Competent Jurisdiction,
  - f. Is recommended for removal from office by a Board of Governors' and Trustees' majority vote of the members present at any General Meeting of the Foundation,
  - g. Ceases to reside in Nigeria.
4. Upon a vacancy occurring in the number of Trustees, a General Meeting will be held to appoint another eligible member of the Foundation.
5. COMMON SEAL:
  1. The Trustees shall have a Common Seal.
  2. Such Common Seal shall be kept in the custody of the Executive Secretary who shall produce it when required for use by the Trustees.
  3. All documents to be executed by the Trustees shall be signed by the Executive Secretary and President and sealed with the Common Seal.

6. AUDITORS:

Shall be appointed by the Board of Trustees, at a General Meeting to audit the Accounts of the Foundation at least once in a year.

(b) The Reports when due shall be submitted to the President who shall communicate same to the General Meeting for an approval.

*Note:* This Enclosure should indicate only the provisions for the appointment of Trustees for their tenure and avoidance of office and method of filling vacancies; and the provisions for the appointment of Auditors. (See paragraphs 3 to 5 of the memorandum for Guidance of Applicants). The full list of Rules should be shown in the constitution.

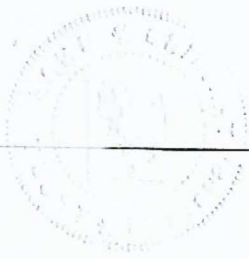
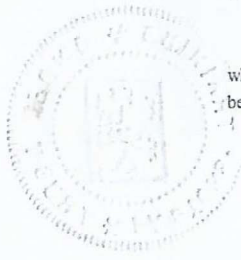
